Introduced innovative approaches to comprehensive planning, including the “staged growth” concept that ties the amount of land planned for development with projected growth.
 - Successfully developed and supervised the adoption of **11 REGIONAL COMPREHENSIVE PLANS** for regions within Berks, Centre, Lancaster, Lebanon and York Counties, PA. These regional comprehensive plans encompassed **43 DIFFERENT MUNICIPALITIES**. Several of these plans were prepared as “models” for regional plan development in Lancaster County by the Lancaster County Planning Commission. These model regional plans included the Solanco Region which was developed as a rural regional plan model and the Donegal Region which was developed as a borough(s)/suburban township regional plan model. Employed a wide range of innovative planning techniques to balance competing issues and resources within each municipality and create broad support for implementation.
 - Successfully drafted and supervised the adoption of **48 ZONING ORDINANCES** for municipalities throughout eastern Pennsylvania, including one joint zoning ordinance for two cooperating boroughs. Many of these ordinances were written immediately following the preparation of a comprehensive plan that was done for the same municipality. Advanced many innovative planning and zoning techniques, including effective agricultural zoning, transferable development rights, mandatory clustering, neotraditional design, performance-based conservation protection, rural cluster design, scenic river protection, historic preservation, and density bonus design standards.
